Deadlines for Review and Approval of Applications

The ORA must be in receipt of the COMPLETE AND FINAL proposal at least 3 Business Days prior to the funding agency deadline.

Definition of Modified Total Direct Costs (MTDC)

MTDC includes all direct salaries and wages, applicable fringe benefits, materials and supplies, services, travel and up to the first \$25,000 of each subaward (regardless of the period of performance). Excludes equipment (>\$5,000, use of >1 year), capital expenditures, charges for patient care, rental costs, tuition remission, scholarships and fellowships, participant support costs and the portion of each subaward in excess of \$25,000.

Definition of Off-Campus

The off-campus rate applies only to activities performed in facilities not owned by the Health Sciences Center and to which rent is charged directly to the project.

Clinical Trial Rate: Industry-Sponsored

The facilities and administrative costs rate for Clinical Trials funded by Industry/Pharmaceutical companies may vary, but must include 20% for core Institutional overhead costs. Departmental or College Administrative cost rates may be included in addition to the Institutional 20%. There will be no exceptions to the core Institutional rate of 20% for Clinical Trials sponsored by Industry/Pharmaceutical companies.

Clinical Trial Rate: Basic Research

The University's current federal negotiated facilities and administrative costs rate applies to all basic research programs sponsored by for-profit Industry/Pharmaceutical companies.
